# INDIAN PRINCELY STATE PIPLODA FISCAL COURT FEES AND REVENUE

STATE: Piploda. Formerly Central India (Malwa) Agency; now in Madhya Pradesh.

LOCATION: Lying generally between 23\*30' north and 75\*

AREA: 72.72 square miles.

POPULATION: 9,627 (1931). VILLAGE: 40.

HISTORY: Little is known of the origin and early history of this state, which is held by a younger branch of the Doria Rajput family of Mandawal, said to have emigrated several centuries ago from Girnar in Junagadh. The same article of the Treaty of Mandsaur (1818) which led to the creation of the Jaora State also guaranteed to Nawab Ghafur Khan "the tribute of Piploda". On the basis of this article an engagement was negotiated by Colonel Northwick with the Nawab and Rawat Prithi Singh in 1820. The tribute payable to Jaora was thus fixed at 28,000 rupees annually, but the relationship between Jaora and Piploda continued to remain a source of controversy for over 100 years. The question was eventually decided in 1923 when the Government of India reaffirmed the status of Piploda as a mediatized state, independent of Jaora.
